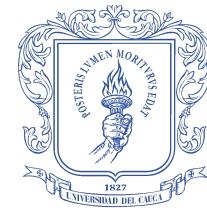

SUBJECT: SCOPE OF DECREE 0572 OF 2025 MINISTRY OF FINANCE AND PUBLIC  
CREDIT MODIFICATION IN THE SELF-RETENTION RATES AND IN MINIMUM BASES  
FOR PRACTICE WITHHOLDING AT SOURCE

Respected University Students:

The Financial Management Division, attached to the Administrative Vice-Rector's Office of the University of Cauca, reports that through Decree 0572 of May 28, 2025, issued by the Ministry of Finance and Public Credit, it modifies the self-withholding rates of income tax and decreases the minimum bases for operations subject to withholding as income and that fall on individuals and legal entities under the ordinary regime.

To apply income tax withholdings to suppliers of goods and services through contracts and advances granted by the University of Cauca, the guide for legalizing advances and the updated withholding table in accordance with the aforementioned Decree must be taken into account. 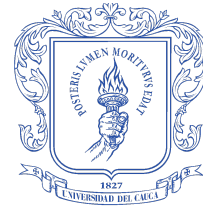
